**Combined Graduate Level Examination (CGLE), 2019 (Tier-III) - Declaration of result for appearing in Skill Test/Document Verification (DV).**

\*\*\*\*\*

The Staff Selection Commission conducted Tier-III (Descriptive Paper) of CGLE 2019 on 22.11.2020. Result of Tier-II, for short-listing of the candidates for evaluation of their Tier-III (Descriptive Paper), was declared by the Commission on 19.02.2021. Based on the result of Tier-II, a total of 43,896 candidates were shortlisted for evaluation of their Tier-III Paper.

2. As per provisions mentioned in the Notice of the aforesaid Examination, "Based on the aggregate performance of qualified candidates in Tier-I, Tier-II and Tier-III Examinations, candidates will be shortlisted to appear in Document Verification/Skill Tests i.e. Computer Proficiency Test (CPT) and Data Entry Skill Test (DEST). Skill Tests where prescribed are mandatory but qualifying in nature. If a candidate does not appear in Skill Test or fails to qualify the Skill Test, he/ she will not be eligible for the posts where CPT/ DEST are mandatory".

3. As per provision of the Notice of Examination (**Para 14.3**), only those candidates have been considered eligible for short-listing to the next stage, who have scored minimum marks in Tier-III Examination as follows:-

- (i) UR : 30%
- (ii) OBC/ EWS : 25%
- (iii) Others : 20%

4. Based on the marks in Tier-I, Tier-II and Tier-III, candidates have been shortlisted for the next stage of examination. Keeping in view the types of posts, the following 04 lists of candidates qualifying for the next stages of examination have been prepared:

I	Assistant Audit Officer (AAO)
II	Junior Statistical Officer (JSO)/ Statistical Investigator Grade-II
III	Posts requiring CPT.
IV	Posts other than mentioned in previous lists (including DEST)

6. Candidates are informed that:-

- i) All the candidates declared qualified in Tier-III will be called for Skill Test/Document Verification.
- ii) All candidates qualified in more than one List need to appear for Skill Test /Document Verification only once. Candidates who do not attend Document Verification will not be considered for final selection.
- iii) Candidates declared qualified in List-III will be called for CPT. The candidates called for CPT will not be called for DEST separately and Module-I of CPT will be taken for evaluating their performance against Data Entry Speed Test (DEST).
- iv) Candidates declared qualified in List-IV (excluding those qualified for CPT) will be called for DEST.
- v) As per provision under Para No. 13.2 of the Notice of the said Examination, detailed options for various posts and departments will be taken from the candidates either online before DV or at the time of Document Verification. A candidate will not be considered for a Post and Ministry/ Department/ Organization, if he/ she has not indicated his/ her preference for it. Options confirmed at the time of Document Verification will be treated as final and will not be changed subsequently under any circumstances. Therefore, candidates are advised to be careful in exercise of such options.

7. Therefore, shortlisted candidates qualified in Tier-I, Tier-II and Tier-III will appear for the Skill Test and Document Verification as per the following:-

List-I & II - In Document Verification.

List-III - In CPT and Document Verification.

List-IV \* - In DEST and Document Verification.

\* Excluding common candidates of List-III.

8. The schedule for CPT/DEST/Document Verification of the qualified candidates will be available on the websites of the concerned Regional Offices in due course. Qualified/eligible candidates, who do not receive call letters, should contact the concerned Regional Offices of the Commission immediately.

9. Marks of the qualified and non-qualified candidates will be uploaded on the website of the Commission on **09.07.2021**. This facility will be made available from **09.07.2021 to 31.07.2021**. Candidates may log in by using their Registered ID and Password.
