

## **STAFF SELECTION COMMISSION**

### **Recruitment of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-Inspectors in CISF Examination, 2017 – Additional list of candidates for appearing in document verification on the basis of DME/ RME.**

\*\*\*\*\*

The Staff Selection Commission had declared the Result of Medical Examination, short-listing candidates for Document Verification vide its write up dated 26.09.2018. The Commission has now received from Central Armed Police Forces (CAPFs) an addition data of 184 candidates of SSC (NR) and 05 candidates of SSC (NWR), who were declared unfit in DME and had subsequently appeared in the Review Medical Examination (RME).

2. The result of Medical Examination (DME/ RME) of the above mentioned 189 (150 male and 39 female) candidates is as follow:-

(i) Male Candidates:

3. As per the details given at Para-2 above, out of 189 candidates, 117 (95 male and 22 female) candidates have been declared as 'Fit' in the RME. Category-wise breakup of these candidates is as follows:

Note-1: Candidates with category OBC (Category Code-6) and 'OBC for Delhi only' (Category Code-4), have been shown under OBC category in the tables mentioned at Para-3 above.

Note-2: Candidates have been categorised based upon their Categories mentioned at the time of filling of online Application Forms.

Note-3: Ex-Servicemen category candidates have been shown in their respective vertical category (i.e. SC, ST, OBC and UR) as well.

4. All the 117 candidates (95 male and 22 female) who have qualified in the RME as per the additional data will be called for the Document Verification by the respective Regional Offices. The Document Verification will commence from 7-10-2018 and detailed schedule of Document Verification will be uploaded on the websites of the concerned Regional/ Sub-Regional Offices.
